Reconciliation Week 2025

The theme for this year's Reconciliation Week was "Bridging Now to Next".

NAIDOC Week

Mallee CMA was proud to partner with local Elders and staff from Parks Victoria, Department of Energy, Environment and Climate Action (DEECA), Forest Fire Management and Agriculture Victoria to celebrate NAIDOC 2025 under the theme of "The Next Generation: Strength, Vision and Legacy."

NAIDOC Week marked a powerful milestone: 50 years of honouring and elevating Indigenous voices, culture and resilience.

This year, the Uncle Ralph Harradine Caring for Country Award was awarded to Jackson Hannah in recognition of his dedication to caring for Country and working with Traditional Owners.

Murray Hardyhead released at Brickworks Billabong

Small but mighty, critically endangered Murray Hardyhead (*Craterocephalus fluviatilis*) fish have found a new home in Brickworks Billabong at Merbein. The collaborative project between the First People of the Millewa Mallee Aboriginal Corporation

and the Mallee CMA saw tiny fish, typically between 30mm to 80mm in size, translocated from Lake Koorlong to Brickworks Billabong, with the aim of further continuing the population growth.

Native Garden Project Hattah-Kulkyne National Park

Based on feedback from Traditional Owners, an exciting new native garden project is underway at the Hattah-Kulkyne National Park Visitor Centre!

As part of The Living Murray project, Mallee CMA is working with Traditional Owners to establish the garden, which will feature an array of native and Bush Tucker plants and herbs, as well as tables and chairs for the public to enjoy. An irrigation system will also be installed to ensure the new plants are well cared for and able to thrive.

The garden is expected to be completed in the coming months.

Aspirations Project Lake Wallawalla

We're working with Traditional Owners, Parks Victoria and the First Peoples of the Millewa-Mallee to protect Lake Wallawalla's cultural heritage.

Around 5kms of decaying fencing will be replaced, and 3kms of new fencing added, to help preserve and protect the important cultural values in this area.

Formal recognition of native title for the First Peoples of the Millewa-Mallee

On 18 July 2025, the Federal Court recognised that the First Peoples of the Millewa-Mallee hold native title over Crown land and waters in the Mallee region.

This is an historic consent determination as it is the first time the Federal Court has recognised native title in Victoria along the Murray River.

It is also the first time in Victoria that the Federal Court has recognised exclusive possession native title rights over certain freehold land owned by Aboriginal organisations.

This is the highest form of native title rights and brings Victoria in line with other Australian jurisdictions.

Any existing interest-holders – such as people with leases or licences over Crown land – are unaffected by this determination.

Mallee CMA congratulates the First Peoples of the Millewa-Mallee and looks forward to continuing to work together to care for Country.

Field work at Lindsay and Wallpolla Islands

A block of field work is currently underway at Lindsay and Wallpolla Islands to inform Cultural Heritage Management Plans (CHMPs) for the Victorian Murray Floodplain Restoration Project (VMFRP). Traditional Owners are working on Country, together with Mallee CMA staff and archaeologists from Ochre Imprints to undertake the field work, which will help further develop the CHMPs.

These CHMPs are an important part of the rigorous environment and planning approvals process (known as an Environment Effects Statement or EES) that is currently being completed for the Lindsay and Wallpolla projects. The EES is expected to be completed this year and will bring together a wide range of information on the potential environmental benefits and impacts of the proposed Lindsay and Wallpolla projects.

Traditional Owners have often mentioned how important it is to them to visit sites during watering. We will be working on making this happen by inviting Traditional Owners to view watering activities. Please keep an eye out for invitations. Events for viewing watering will be unpaid events.

Water Literacy Program

Feedback from participants who attended the Water Literacy program has been really positive, with 6 sessions delivered to Traditional Owner groups over the past 6 months.

These sessions – which are knowledge sharing opportunities about how the Murray River works – have received some great feedback from participants, including:

- "We go to lots of engagement things but this really shows a good demonstration and is a lot more interesting."
- "The main activity is in line with how we learn, via a hands on and visual approach, and telling a story in the natural environment."
- "Improving our water knowledge will help us in dealings with government organisations. We want to make real changes, not just tick a box in a project."

The Water Literacy program has strengthened partnerships with Traditional Owners in the Mallee CMA region and increased the level of understanding of water-related topics.

Traditional Owners say they feel more empowered to contribute to natural resource management initiatives and conversations about collaborative efforts to combat the effects of river regulation on the Mallee landscape.

In particular, Traditional Owner groups have said they want to maintain the interactive learning approach, methods and materials used to convey complex water-related information. In response to this, additional sessions will be run this year and planning is now underway. We will be in touch with Traditional Owner groups as details are confirmed.

The Mallee CMA Aboriginal Engagement Team really enjoyed the chance to connect with everyone who participated, and we thank each and every one of you for your valuable time.

Fun Facts: Spotlight on Threatened Species

Mallee Emu-wren

- 1) Australia's smallest bird by weight, coming in at an average of 5 grams
- 2) Name derived from their long, decorative tail feathers which resemble an emu's
- Mainly use the spiky Triodia grasses for shelter and breeding. May help thermoregulate and provide protection against predators.
- 4) Recently taken into captivity for the first time, where they are showing great breeding success.
- 5) Have disappeared from much of their historic range including from the entire South Australia largely as a result of large-scale bushfires and fragmented habitat. Only 3 known populations remain, all in Victoria.
